<p>Do you Qualify for the EITC?</p> <ul style="list-style-type: none"> • If No children: Income maximum is less than \$13,460 (S, HH, QW) or \$18,470(MJ); credit maximum is \$457 • If One Child: Income maximum is less than \$35,535 (S, HH, QW) or \$40,545 (MJ); credit maximum is \$3,050 • If Two Children: Income maximum is less than \$40,363 (S, HH, QW) or \$45,373(MJ); credit maximum is \$5,036 • If Three or more Children: Income maximum is less than \$43,352 (S, HH, QW) or \$48,362 (MJ); credit maximum is \$5,666 <p>S: Single; HH: household QW: Qualifying Widows/Widowers MJ: Married filing jointly</p>	<p>What to Bring</p> <ul style="list-style-type: none"> • Your spouse if filing jointly • Your Valid picture ID • All Social Security CARD(s) [or official SSA document proving your Social Security number(s)], for you, your spouse, children and any others shown on the tax return CANNOT FILE WITHOUT IT! • Copies of ALL W-2s, 1098s, 1099s, Social Security statement, and the amount of other income received by you & your spouse, if applicable • A copy of your 2009 tax return is helpful • Child/Dependent Care provider's tax ID number • Student loan interest/college tuition expenses paid • Form 8332 for non-custodial parent claiming child • If you are direct depositing your refund into your checking or savings account, bring proof of account number & routing transit number of the financial institution – a copy of a voided check • Additional documentation to claim possible tax credits
